ORDER

Whereas, the Kangra Adarsh CGHS Ltd., Plot No.377-A, Kangra Niketan, Vikaspuri, New Delhi-110018, registered vide Registration No. 33/GH with this department under the provision of DCS Act, 2003 and Rules 2007 framed there under and registered Bye-Laws of the society.

Whereas, Secretary of Society vide his letter dated 04.04.2025 has requested to appoint Inquiry Officer as per the direction of the court of Financial Commissioner in the revision petition bearing no.169/2024 titled The Kangra Adarsh CGHS Ltd. Vs Special Registrar Cooperative Societies & Ors.

Now, therefore, in exercise of the powers vested u/s 61 of DCS Act, 2003, the Competent Authority has approved to appoint Sh. Manmeet Singh Walia, Jt. Secretary, Law Department (9818660304) as an Inspecting Officer u/s 61 to conduct an inquiry on the following points on complaint dated 07.02.2022:-

1. Registration of trust namely 'Shiv Shakti Mandir Sewa Trust' for which the erstwhile Management Committee issued NOC on behalf of the society for registration of the said trust which is the violation of Rule 110 (6) of the DCS Rules, 2007.
2. Typed minutes of the meeting has been pasted on the last page of the proceeding register after closure of the register and it alleged in the complaint that purported minute of the meeting dated 10.08.2020, pasted after the duly recorded handwritten minutes of meeting dated 03.09.2020 which prima facie amounts to falsifying/tampering of the records of the Cooperative Society.

This inquiry has to be completed within 60 days of his appointment. He will be paid Rs.15000/- as a cost of inspection from the society fund.

This issues with the prior approval of Competent Authority.
