ORDER U/S 35(5) OF DCS ACT, 2003

Whereas, *Ekjot Co-operative Group Housing Society Ltd.* (Regd. No. 110/GH), situated at Road No. 44, Pitampura, Delhi-110034, is registered with this Department under the provisions of the Delhi Cooperative Societies Act, 2003, the Rules framed thereunder, and the Bye-laws of the Society.

And whereas, Sh. Shiv Ram Bairwa, Retd. Secretary (RERA), was appointed as Administrator-cum-Returning Officer of the aforesaid Society vide this office order dated 20.03.2026. However, he has expressed his inability to work as Administrator-cum-Returning Officer and has also not joined the Society.

And whereas, the Registrar, Cooperative Societies has considered the matter and the appointment of Sh. T.P. Singh, Retd. Section Officer as Administrator-cum-Returning Officer under Section 35(5) of the DCS Act, 2003 in respect of Ekjot CGHS Ltd., with immediate effect. The Administrator so appointed shall conduct the election of the Managing Committee within a stipulated period of ninety (90) days from the date of his appointment. He shall be paid remuneration of ₹10,000/- (Rupees Ten Thousand Only) per month plus applicable Travelling Allowance, to be borne from the funds of the Society. And he will be also submitting monthly progress report about the status of affairs of the society by 10th of every month.

Further, Sh. Rajender Babu Shukla, the then Administrator, is hereby directed to hand over the charge of all relevant records and documents of the Society to Sh. T.P. Singh, Retd. Section Officer immediately, under intimation to this office.
