**CIRCULAR**

The United Nations has declared the Year 2025 as the International Year of Cooperation (IYC 2025), with the theme (cooperative build a better world) and the Hon'ble Prime Minister of India formally announced this during the inaugural session of the International Cooperative Alliance (ICA) General Assembly and Global Conference in New Delhi.

To mark this significant yearlong celebration, the Secretary (Cooperation), GOI has given direction to all the participants of cooperative sector to run a program/campaign with Deptt. of Forest and Environment for starting a program "Ek Ped Maa Ke Naam" campaign.

Further, 5<sup>th</sup> July, 2025 being first Saturday of July month will be celebrated as International Cooperative Day with theme **"Cooperatives: Driving Inclusive and Sustainable Solutions for a Better World"**. This cooperative Day will be serve as a flagship moment within the United Nations International Year of Cooperatives (IYC 2025)---- a once-in-a-decade opportunity to spotlight the critical role of cooperatives in building more inclusive, resilient, and sustainable communities.

Additionally, 6<sup>th</sup> July 2025 will mark the 4<sup>th</sup> Foundation Day of Ministry of Cooperation, which was established as a separate Ministry in 2021 to strengthen the cooperative movement through a dedicated and focussed approach & it is informed by Ministry of Cooperation that it is planning to celebrate first week of July (1<sup>st</sup> to 6<sup>th</sup> July) through a series of diverse and impactful activities. In this week various activities like plantation drives, Model auditing, AGMs, State/National Level conferences walkathon, lectures, Swachhta Campaigns etc can be organised at national, state, district, and primary levels. An activity calendar for this week has also been prepared and attached herewith.

Therefore, in light of these significant occasions, vide this department's circular No. F.47/Policy/RCS/21/2016/354 dated 16.06.2025, all the Cooperative Group Housing/Building Societies, Urban Cooperative Banks, Thrift & Credit Societies, DCCWS Ltd., DCHFC Ltd., Federations/Unions & all other kind of cooperative societies were directed to ensure participation in celebration of first week of July (1<sup>st</sup> to 6<sup>th</sup> July) through a series of diverse and impactful activities.

In view of the above, please find enclosed herewith a list of Nursery of Forest Department in GNCT of Delhi alongwith name and Phone No. of contact person who shall be contacted for collection of the saplings/plants by all the Group Housing/Building Societies under the "Ek Ped Maa Ke Naam" campaign and Sehkar Vatika in all the CGHS/CHBS societies.

Further, it is reiterated that widespread participation from all these cooperative societies/unions/federations/banks be ensured and photographs of the same shall be shared with O/o Registrar Cooperative Societies, GNCT of Delhi for further submission to Ministry of Cooperation, GOI.
