**ORDER**

Whereas Jai Lakshmi Co-operative GHS Ltd. is registered vide Registration No.270-GH with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the society.

And whereas, the existing Administrator-cum-R.O. Sh. M.K.Gupta's tenure was expired on 17.03.2025 and numbers of representations from the members of the society have been received in this office for replacing of Sh. M.K.Gupta, current Administrator-cum-R.O. **The past period of Sh. M.K.Gupta as an Administrator-Cum-R.O. w.e.f. 18.03.2025 to the date of issue of this order is being regularized.** Thereafter, Sh. Rakesh Kumar Gaur, Retd. DANICS was appointed as Administrator-Cum-R.O in place of Sh. M.K.Gupta vide this office order no. 261-264 dated 09.04.2025. In the meantime, Sh. Rakesh Kumar Gaur, Retd. DANICS requested vide application dated 15.04.2025 that he is pre-occupied in some domestic and social commitments for the next 02 months and he would not able to take up the assignment of Administrator - cum - R.O. in the society. Thereafter, Sh. Subhash Gupta (Retd. DANICS) was appointed as Administrator-Cum-R.O in place of Sh. Rakesh Kumar Gaur, Retd. DANICS vide this office order no. 312-315 dated 29.04.2025, In the meantime, Sh. Subhash Gupta (Retd. DANICS) requested vide application dated 01.05.2025 that due to some personal reasons he is unable to spare time to take this assignment as Administrator-Cum-R.O in the society.

Now therefore, I, Satish Kumar Gupta, Assistant Registrar (GH/Sec-III) hereby convey the approval of the Competent Authority to appoint **Sh. Kewal Singh, Joint C.P (Retd.) as Administrator-Cum-Returning Officer** in place of Sh. M.K.Gupta in Jai Lakshmi Co-operative GHS Ltd. (Regn.
