ORDER U/S 35(5) OF DCS ACT, 2003

Whereas, Eklavya Vihar Co-operative Group Housing Society Ltd. (Regn. No. 564/GH) is registered with this department under the provisions of DCS Act & Rules and Bye-Laws of the Society.

And whereas, the representation dated 19.06.2025 was received from Narender Kumar Jain Vice President/Treasurer of the society wherein it is informed that tenure of Management Committee has officially concluded in November 2024. Due to the former president's unforeseen and prolonged ill health, it was delayed formally notifying to the office about the expiration of their term.

And whereas, the Registrar Co-operative societies has considered the matter and approved the name of Sh. Harvinder Kumar, Dy. Director (M/o finance) for the appointment of Administrative –Cum-Returning Officer under Section 35(5) of DCS Act, 2003 in Eklavya Vihar Co-operative Group Housing Society Ltd. with immediate effect. A remuneration of Rs. 10,000/-(Rupees Ten Thousand Only) per month and Travelling Allowance applicable shall be paid from the fund of the society and to hold the election of the Management Committee of the Society within stipulated period of 90 days from the date of appointment as Administrator-cum-Returning Officer.

The Ex- Management Committee of Eklavya Vihar Co-operative Group Housing Society Ltd. is hereby directed to handover the charge of the record of the Society/relevant documents to the Administrator-Cum-Returning Officer immediately under intimation to this office within 07 days from the issue of this order.
