Whereas Defence Ministry Employees CGHS Ltd., Raksh Kunj, Paschim Vihar, New Delhi-110063 is registered vide registration No.101-GH with this department under the provision of DCS Act & Rules and Bye-laws of the society.

And whereas, the representation dated 24.07.2025 was received from Sh. Mayor Kumar, member of the society wherein it is informed that election of the Managing Committee was formed in November 2020 and there was not requisite Secretary and Treasurer as both the positions fell vacant more than a year back as both expired being very. The elections of the Management Committee of the society is overdue now.

And whereas, the Registrar Co-Operative Societies has considered the matter and approved for the appointment of Sh. T.P. Singh, Retd. Section Officer/ Grade-I DASS as Administrator, under section 35(5) of DCT Act, 2003 of Defence Ministry Employees CGHS Ltd. with effect as the Management Committee already expired. The administrator appointed by the Registrar shall also hold election within ninety days from the date of his appointment. A remuneration of Rs.10,000/- (Rupees Ten Thousand Only) per month and Travelling Allowance applicable shall be paid from the funds of the society.

The Ex-management Committee of Defence Ministry Employees CGHS Ltd. is hereby directed to handover the charge of the record of the society/relevant documents to the Administrator immediately under intimation to this office within 07 days from the issue of this order.
