Subject: Ad-hoc Monthly Relief (AMR) to the J&K Migrants.

Sir Ma'am.

This is with reference to the J&K Migrant cards issued by GNCTD for Ad-hoc Monthly Relief. In the cases where aadhaar details of some family members are received, the competent authority has approved the following:

1. The Ad-hoc Monthly Relief (AMR) may be released only for those individuals within the family whose aadhaar details are submitted. The AMR may not be released for the individuals within the family whose aadhaar details are not submitted. Payment of arrears for those families whose AMR has not been released for any reason may be released on the same principle.
2. Restriction on release of AMR, due to non-submission of Aadhar will not give effect to deletion of those names. Addition/deletion of names and bifurcation of family will be done only as per extant norms and established guidelines.

All the Revenue Districts are directed to process the payments of Ad-hoc Monthly Relief (including arrears) based on the above directions. The Revenue Districts are further directed to invite the Self Declaration form for the F.Y 2025-26 from the J&K Migrant Families and process for the payment as per rules.
