The Recommendation of Screening Committee is subject to the following conditions:

1. The financial upgradation under the Modified Assured Career Progression (MACP) Scheme shall be regulated in accordance with DoP&T O.M. No. 35034/3/2008-Estt.(D) dated 19.05.2009, read with subsequent amendments/clarifications issued from time to time. The benefit under MACP Scheme will be admissible to all the officials.
2. The pay of the officials shall be fixed under the provisions of FR 22(I)(a)(1) and other applicable Government of India/Delhi Jal Board instructions. The officials concerned may exercise the option for pay fixation, wherever admissible, within one month from the date of issue of this Office Order, in terms of Dy. Director (F&A)-I Letter No.

DJB/ACA/(F&G)/2010/38810 dated 29.04.2010, read with Corrigendum No. DJB/ACA/F&G/2009/39737 dated 30.04.2010.

3. Before allowing the financial upgradation and fixing the pay, the Drawing & Disbursing Officer (DDO) concerned shall verify that the official has completed the prescribed qualifying service under the ACP/MACP Scheme, as applicable, has not been granted any inadmissible financial upgradation/promotion earlier, is clear from the vigilance angle, and was not under the currency of any penalty on the due date of financial upgradation.
4. The financial upgradation under the ACP/MACP Scheme shall be purely personal to the employee and shall amount only to placement in the immediate next higher Pay Level/Grade Pay. It shall not be treated as a functional or regular promotion, nor shall it confer any right relating to seniority, designation or higher responsibilities.
5. The grant of financial upgradation shall be subject to audit verification. In the event of any discrepancy or ineligibility being noticed subsequently, this Office Order shall be liable to be modified, withdrawn or cancelled, and any excess payment made on this account shall be recoverable from the concerned official in accordance with the applicable rules.
