ORDER UNDER SECTION 61 OF DCS ACT, 2003

Whereas, The Ministry of Labour & Employment & Attached & Subordinate Offices Co-operative Thrift & Credit Society Ltd. is registered with this department under the provisions of the DCS Act, 2003 and Rules framed thereunder;

And whereas, a petition has been filed by Sh. Rajinder Kumar Bhasin regarding non-payment of matured FDR amount by the Society;

And whereas, the dispute was adjudicated by the Ld. Arbitrator vide award dated 24.01.2025, directing the Society to repay the amount at a minimum rate of ₹4,00,000/- per month, however, the Society failed to comply with the said award and continued partial payments in violation thereof;

And whereas, the Society preferred an appeal before the Hon'ble Delhi Co-operative Tribunal (Appeal No. 29/2025/DCT), which was dismissed vide order dated 20.01.2026 with costs of ₹50,000/-, directing refund of the entire amount along with applicable interest and further cost @ ₹5,000/- per month in case of non-compliance;

And whereas, the Hon'ble Tribunal observed that the Society is not competent to run its affairs and directed the Registrar, Co-operative Societies to examine the matter for necessary enquiry and appropriate action including cancellation of license;

And whereas, a Contempt Petition (Civil) under Section 12 of the Contempt of Courts Act, 1971 has also been filed before the Hon'ble High Court for non-compliance of the aforesaid order;

Now therefore, I, Rakesh Kumar, Deputy Registrar (T&C), hereby convey the approval of the Competent Authority to appoint Sh. Joseph Baxla, Deputy Registrar, as Inspection Officer under Section 61 of the DCS Act, 2003.

The Society shall pay ₹15,000/- (Rupees Fifteen Thousand Only) as remuneration to the Inspection Officer from the funds of the Society for conducting the inspection on the above issues.

The Inspection Officer shall complete the inspection and submit his report within 60 days of issue of this order.

This issues with the prior approval of the Competent Authority.
