ORDER U/S 35(5) OF DCS ACT, 2003

Whereas DIN CGHS Ltd., plot no. 7, Sector-04, Dwarka, Phase-1, New Delhi-110078 is registered vide registration No.852 (GH) with this department under the provision of DCS Act & Rules and Bye-laws of the society.

Whereas Sh. Tariq Salam, Retd. DANICS officer, was appointed as Administrator vide this office order dated 06.03.2025, and his tenure was subsequently extended for a period of 90 days vide order dated 08.07.2025. The extended tenure has now expired on 05.09.2025. Subsequently, Sh. Tariq Salam has expressed his inability to continue in the present assignment due to medical complications and is currently undergoing calf surgery.

And whereas, the Registrar Co-Operative Societies has now approved that Sh. Rajender Babu Shukla, Retd. The administrator appointed by the Registrar shall also hold election within ninety days from the date of his appointment. A remuneration of Rs.10,000/- (Rupees Ten Thousand Only) per month and Travelling Allowance applicable shall be paid from the funds of the society.

Sh. Tariq Salam, Retd., DANICS, the then Administrator is hereby directed to handover the charge of the record of the society/ relevant documents to Sh. Rajender Babu Shukla, Retd. Section Officer (Grade-I DASS), Administrator immediately under intimation to this office.
