This order shall dispose of the proceedings initiated vide Show Cause Notice dated 29.09.2024 issued under sections 37 of DCS Act 2003.

It is noted from the record that despite issuance of repeated notices and opportunities of hearing, the MC of Chitra T/C Society has failed to file its reply to the Show Cause Notice dated 23.09.2024 and has not appeared before RCS on any of the dates of hearing. Such conduct establishes that the Society is neither interested in persuing the matter nor inclined to comply with the lawful directions of the RCS. Nevertheless, in order to safeguard the principles of natural justice, a Bailiff was deputed on 06.08.2025 to effect service of notice upon the Society. The Bailiff has submitted his report to the effect that the office of Chitra T/C Society situated at H-17, Sector-07, Ronihi, Delhi-85 has remained closed for the past one year and no office bearers or staff were found available at the premises.

In view of the aforesaid facts and circumstances, and in taking into account the Bailiff's report dated 06.08.2025 stating that the office of Chitra T/C Society situated at H-17, Sector-07, Ronihi, Delhi-85 has remained closed for the past one year with no office bearers or staff available, it stands established that the Society has willfully failed to participate in the proceedings for more than a year. Accordingly, the present matter is decided ex-parte and the existing Managing Committee of Chitra T/C Society is hereby superseded. Sh. Amresh Chandra Chaudhary (AAO) is appointed as Administrator of the Society with immediate effect, who shall take charge forthwith and perform all functions of the Managing Committee in accordance with the provisions of the DCS Act and Rules until further orders. The Administrator shall further submit a progress report to the RCS every 15 days regarding the functioning and status of the Society.
