ORDER

Whereas, the Lion's Cooperative Group Housing Society Ltd, Outer Ring Road, J Block, Vikas Puri, Delhi-18 is registered vide Registration No. 305/GH with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the society.

And whereas, Sh. A.K. Sharma was appointed as Administrator of Lion's CGHS Ltd. u/s 35(5) of DCS Act, 2003 vide this office order dated 10.10.2024 for 90 days to look after the day to day affairs of the society and to conduct elections of the new Managing Committee of the society and also submit a monthly status report of the society in this office.

Further, Administrator of Lion's CGHS Ltd. requested to extend his period of Administrator of the said society for further 90 days.
