ORDER

Whereas, Delhi State Cooperative Union Limited, 46-Brij Mohan Marg, Darya Ganj, New Delhi-110002 (hereinafter referred to as "the Society") is a cooperative society registered with this Department under the provisions of the Delhi Cooperative Societies Act, 2003 (hereinafter referred to as "the Act") and the rules framed thereunder;

And whereas, vide this Department's Order No. F.47/AR/BKG/RCS/262/2025/2914 dated 20.01.2026, Shri J K Sharma (IPS, Retd.) was appointed as Returning Officer of the Society for the purpose of conducting elections to the Managing Committee under Section 35(1) of the Act.

And whereas, Shri J K Sharma (IPS, Retd.) has expressed that due to certain administrative and unavoidable circumstances the election to the Society could not take place so far but the same are proposed to be held shortly.

And whereas, Shri J K Sharma (IPS, Retd.) has requested that his tenure as Returning Officer of the Society be further extended to enable him to undertake this exercise as early as possible.

And whereas, it is imperative in public interest and in the interest of the Society that the election process is conducted and completed within the prescribed time frame, in accordance with law and the directions of the Registrar Cooperative Societies;

Now, therefore, in exercise of the powers conferred under Section 35(1) of the Delhi Cooperative Societies Act, 2003, and with the prior approval of the Competent Authority, the undersigned hereby extends the tenure of Shri J. K. Sharma, IPS (Retd.) for a period of 90 days as Returning Officer of Delhi State Cooperative Union Limited, for the purpose of conducting elections to the Managing Committee of the Society.

Shri J. K. Sharma, IPS (Retd.), shall take all necessary steps to conduct and complete the entire election process within a period of ninety (90) days from the date of issue of this order, strictly in compliance with the provisions of the Delhi Cooperative Societies Act, 2003, the Delhi Cooperative Societies Rules, 2007, and the election guidelines prescribed under Rule 53 read with Schedule-II of the said Rules.

The remuneration payable to the Returning Officer shall be ₹10,000/- (Rupees Ten Thousand only), to be paid from the funds of the Society. All expenses incidental to the conduct of elections shall be borne by the Society.

The elections to the Managing Committee of the Society shall be conducted in a free, fair, transparent, and impartial manner, without any interference from any individual or authority, except as permissible under law.

The General Secretary of the Society shall extend full cooperation and shall provide all requisite records, documents, infrastructure, and logistical support to the Returning Officer to ensure smooth and timely conduct of elections.

This issues with the prior approval of the Competent Authority.
