**ORDER FOR FURTHER EXTENSION UNDER SECTION 61 OF THE DELHI CO-OPERATIVE
SOCIETIES ACT, 2003**

Whereas, the *Ministry of Labour & Employment & Attached & Subordinate Offices Co-operative (Urban) Thrift & Credit Society Ltd.*, Shram Shakti Bhawan, Rafi Marg, New Delhi, is registered with this Department under the provisions of the Delhi Co-operative Societies Act, 2003 and the Rules framed thereunder;

And whereas, a complaint/petition was filed by Sh. Rajinder Kumar Bhasin regarding non-payment of matured FDR amount by the Society;

And whereas, an order under Section 61 of the Delhi Co-operative Societies Act, 2003 was issued vide F.No.47/AR/BKG/RCS/2026/1469-71 dated 17.04.2026, whereby Sh. Joseph Baxla, Deputy Registrar, was appointed as Inspection Officer to conduct inspection into the affairs of the Society and submit the Inspection Report within 60 days.

And whereas, Sh. Joseph Baxla, Deputy Registrar/Inspection Officer, submitted a request dated 13.07.2026 to the Registrar, Co-operative Societies, seeking further extension of time for submission of the Inspection Report, stating that the complete records/documents relevant to the matter were required for conducting a proper and comprehensive inspection;

And whereas, the Inspection Officer was also deputed as Assistant Returning Officer in connection with the NCUI Elections vide Order No. CEA-12011/253/2025 dated 26.05.2026, which also affected the time available for completion of the inspection.

And whereas, considering the circumstances stated by the Inspection Officer and the requirement of examining the complete relevant records/documents for conducting a proper and comprehensive inspection, the Competent Authority has accorded approval on 03.08.2026 for granting a further period of 60 (sixty) days for submission of the Inspection Report;

Now, therefore, in exercise of the powers under Section 61 of the Delhi Co-operative Societies Act, 2003, and with the approval of the Competent Authority, the time for submission of the Inspection Report by Sh. Joseph Baxla, Deputy Registrar/Inspection Officer, is hereby further extended for a period of 60 (sixty) days.

The Inspection Officer shall complete the inspection and submit his comprehensive and reasoned Inspection Report within the extended period, after obtaining and examining all relevant records/documents pertaining to the matter.

All other terms and conditions contained in the original order dated 17.04.2026 shall remain unchanged and shall continue to be applicable.
