**ORDER U/S 35(5) OF DCS ACT, 2003**

Whereas, Chitrakut Co-operative Group Housing Society Ltd. is registered with this department under the provisions of DCS Act & Rules and Bye-Laws of the Society

Whereas, the grievance of Sh. N.K. Goel regarding non-appointment of Administrator in the non-functioning society Chitrakut CGHS Ltd. was received and examined.

And whereas, the society has failed to convene Annual General Meetings and conduct statutory audits since 2012, in violation of the provisions of the Delhi Cooperative Societies Act, 2003.

And whereas, the Registrar Co-operative societies has considered the matter and approved the name of Sh. R. S. Krishnan, Dy. Secretary, O/o Chief Secretary, GNCTD for the appointment of Administrative -Cum-Returning Officer under Section 35(5) of DCS Act, 2003 in Chitrakut Co-operative Group Housing Society Ltd. with immediate effect. A remuneration of Rs. 10,000/-(Rupees Ten Thousand Only) per month and Travelling Allowance applicable shall be paid from the fund of the society and to hold the election of the Management Committee of the Society within stipulated period of 90 days from the date of appointment as Administrator-cum-Returning Officer.
