Whereas The General CGHS LTD., Plot No. 37, I.P. Extension, Patparganj, Delhi-110092 is registered vide Registration No.265-GH with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the society.

And whereas, due to seven management committee members of the society of Sh. R.K. Khandelwal (Secretary), Smt. Seema Gupta (Joint Secretary), Sh. Ravinder Jha (Treasurer), Sh. Ramesh Chander (Member), Sh. D.S. Yadav (Member), Sh. Om Parkash Wadhwa (Member) and Dr. Bobby Dewan (Member) have resigned vide dated 27/04/2025. So, only two members are left in the Management Committee, which are insufficient to run the M.C of the society under the DCS Act & Rules.

In this regard, as per provision of DCS Act, 2003 & Rules, 2007 are stated that the Managing Committee should have at least 5 members of the committee.

Now therefore, I, Satish Kumar Gupta, Assistant Registrar (GH/Sec-III) hereby convey the approval of the Competent Authority to appoint Sh. Kulanand Joshi, IAS (Retd.) as Administrator-cum-RO in The General CGHS LTD., Plot No. 37, I.P. Extension, Delhi-110092 under section 35 (5) of DCS Act, 2003 to look after the day-to-day affairs of the society and to conduct the election of the M.C. within 90 days from the issue of this order.

He will be paid Rs.10,000/- (Rupees Ten Thousand Only) per month as remuneration and conveyance from the society funds for this purpose.
