SHOW CAUSE NOTICE

Whereas, Jaypee CGHS Ltd. (Regn. No. 654/GH) is registered with this department under the provisions of DCS Act/Rules & Registered Bye Laws of the Society.

And Whereas, Ms. Mahnaz Ansari R/o C-3/113, Sobha City, Dwarka Expressway, Sector 108, gurugram, Haryana-122017 had submitted applications vide dated 04/06/2024 for seeking information U/s 139 of DCS Act, 2003 to the society. But the society did not reply within stipulated time.

When the appellant file second appeal in CIC via appeal no. CIC/COPSO/A/2024/650956. In this regard CIC stated:

The appeal dated 04/06/2024 is self explanatory and the society misrepresented saying that the response has been given. The letters containing the response of the society were returned back to the society by the Postman and when the society approached by the appellant (in person), the letter in response to the RTI from the society were withheld by the Secretary/PIO.

Despite giving notices to the society, none of them appeared and no information is provided to the appellant till date.

And therefore, I Deputy Registrar Cooperative Societies, Govt. Of NCT of Delhi in exercise of powers vested in under the provisions of the Delhi Cooperative Societies Act, 2003 & Rules, 2007, it is hereby call upon the President/Secretary to Show Cause as to why a penalty be not imposed against the M.C of Jaypee CGHS Ltd. for not replying/present before the authority. Reply to this notice must be filed within 05 days from the receipt of this notice, failing which it will be assumed that the M.C. of the society has nothing to say in its defense and penalty may be impose of Rs. 10,000/- under section 139 of DCS Act, 2003 read with Rule 165 (8) of DCS Rules, 2007.
