ORDER

Whereas **Ganga Triveni CGHS Ltd.**, Plot No. 24/1, Sector-9, Rohini, Delhi-110085 is registered vide Registration No. 276-GH with this department under the provisions of Delhi Co-operative Societies Act/Rules & registered Bye-Laws of the society.

Vide letter dated 25/05/2025, The Vice President/Secretary of the society requested this office to appoint a Returning Officer to conduct the election of the M.C of the society u/s 35(1) at the earliest. The last election of the society was held on 29/06/2022.

Now therefore, I, Satish Kumar Gupta, Assistant Registrar (GH/Sec-III) O/o RCS, hereby convey the approval of the Competent Authority to appoint Sh. Somir Kumar Sikdar alias (S.K. Sikdar), Retd.
