Subject: Re - Nomination of Delhi Jal Board Dispensaries as "Delhi Jal Board Arogya Mandir".

In pursuance of the initiative to strengthen and modernize the primary healthcare services being provided to the employees, pensioners and their eligible dependents of Delhi Jal Board, it has been decided by the Competent Authority that all the existing Delhi Jal Board Dispensaries shall henceforth be re-nominated as "Delhi Jal Board Arogya Mandir" with immediate effect.

Accordingly, the nomenclature of all DJB Dispensaries shall stand revised as "Delhi Jal Board Arogya Mandir" in all official records, correspondence, signage, stationery, reports, websites and other related documents. It is further clarified that:

1. The change is only in the nomenclature of the existing dispensaries. The location, administrative control, manpower and existing healthcare services shall continue to remain unchanged.
2. All DDOs/MOIs/In-charges of the respective Delhi Jal Board Arogya Mandir shall ensure that the revised nomenclature is adopted in all official communications and records with immediate effect.
3. Necessary action for replacement of signboards, name plates, rubber stamp and other display materials shall be taken by the concerned division at the earliest.
