Whereas, the Nav Rattan CGHS Ltd. Plot No.7A, Sector-23, Dwarka, New Delhi-110077 is registered with this department at Regn. No. 1170 (GH) under the provisions of DCS Act and Rules.

Whereas, Sh. Mohan Chand Gaur, was appointed as an Administrator-cum-Returning Officer U/s 35(5) of the DCS Act, 2003, in Navrattan CGHS Ltd. vide this office Order dated 21.10.2024 for 90 days and further his tenure was extended by the Competent Authority vide this Office Order dated 28.01.2025 for another 90 days.

Whereas, the Competent Authority has decided to divest Sh. Mohan Chand Gaur from the charge of Administrator-cum-RO appointed under section 35(5) of DCS Act, 2003 in the above said society with immediate effect, since, he has not conducted the elections for formation of new Management Committee in the said society and also his tenure as an Administrator-cum-RO has expired on 22.04.2025.

Now, therefore, the undersigned is directed to convey the approval of Worthy Registrar Co-operative Societies, GNCT of Delhi in exercise of the powers vested in him under DCS Act 2003 & Rules 2007, is pleased to **appoint Sh. Ram Kumar Savant, Section Officer (Grade-I)** u/s 35(5) of the DCS Act 2003 for next 90(Ninety) days to manage the affairs of the society and conduct the election of the Managing Committee of the Navrattan CGHS Ltd. as per the guidelines for the elections available in Rule 53 of Schedule II of DCS Rules, 2007. The Administrator-cum-R.O., on expiry of the period of next 90 days will not exercise any financial powers till the term is further extended by the Competent Authority. An honorarium of Rs.10,000/-(Rupees Ten Thousand Only) per Month plus other expenses will be paid to him from the society funds.
