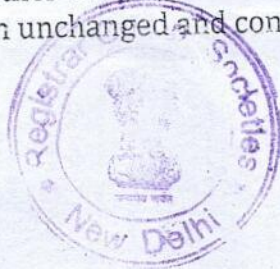
Order
