ORDER

In pursuance of approval of the Competent Authority and for effective coordination, monitoring and policy level handling of matters related to implementation of the PM-UDAY Scheme, a dedicated PM-UDAY Cell is hereby constituted at Revenue Headquarters with immediate effect.

- Policy matters and examination of PM-UDAY related issues.

- Grievance handling and facilitation support, preparation of reports, review material and data compilation for senior officers.
- Infrastructure related issues and coordination with BISAG, survey agencies, etc.
- Post creation, creation of budget head, etc.
- Any other issue assigned by the Competent Authority for smooth implementation of the PM-UDAY Scheme.
