Whereas, the New Cosmopolitan CGHS Ltd., Plot No.-33, Sector-10, Dwarka, New Delhi-110075 is registered with this department at Regd. No. 1215/GH under the provisions of DCS Act and Rules.

Whereas, Sh. V.K. Rastogi, was appointed as an Administrator-cum-Returning Officer U/s 35(5) of the DCS Act, 2003, in the New Cosmopolitan CGHS Ltd. vide this office Order dated 04.03.2025 for 90 days and his tenure has expired on 04.06.2025.

Now, therefore, the undersigned is directed to convey the approval of Worthy Registrar Co-operative Societies, GNCT of Delhi in exercise of the powers vested in him under DCS Act 2003 & Rules 2007, to divest the charge from Sh. V.K. Rastogi and to **appoint Sh. Vinod Kumar Mishra, Section Officer (Grade-I)** u/s 35(5) of the DCS Act 2003 for next 90(Ninety) days to manage the affairs of the society and conduct the election of the Managing Committee of the New Cosmopolitan CGHS Ltd., as per the guidelines for the elections available in Rule 53 of Schedule II of DCS Rules, 2007.
