And whereas, a representation dated 10.01.2025 has been received from Sh. Jagdish Prasad, vide which it has been requested to appoint an Administrator in the society as there is no Managing Committee is functioning in the society since long time and Sh. Ajay Arora, who was lastly appointed as Administrator vide this office order dated 07.08.2023, did not join as Administrator in society.

Now, therefore, in view of the request in this regard, I, Suman Kumari, Assistant Registrar (SEC-VII/H) hereby convey the approval of the Registrar, Cooperative Societies to appoint Sh. Kuldeep Kumar, Section Officer (Central Administrative Tribunal), as Administrator in Swayam Sidha Co-operative Group Housing Society Ltd., Punjabi Bagh (West), Near Shiv Mandir, New Delhi-110026 under section 35(5) of Delhi Co-Operative Societies Act, 2003 to manage the day to day affairs of the society and to re-establish the democratic setup in the society within a period of 90 days by way of conducting the election of the Managing Committee of the society as per the Rule 53 & Schedule II of the DCS Rules, 2007.

Further, the Administrator shall draw a sum of Rs. 10,000/- (Rs. Ten thousand only) as honorarium along with conveyance charges and other election expenses from the funds of the society.
