Order under Section 139 of DCS Act, 2003

This order shall dispose of The appeal dated 16/11/2022 filed by Ms Maya Modak, who has sought information u/s 139 of DCS Act, 2003 vide his application dated 22/10/2022 from President/Secretary, Sahyog CGHS Ltd., The Appellant has stated in the Appeal that no complete/satisfactory reply has been furnished by the Respondent Society although the period prescribed for giving reply is over.

Notices were issued for hearing on 27/03/2023, 10/04/2023, 09/06/2023, 26/06/2023, 25/07/2023 and a order dated 10/10/2023 was issued with direction to respondent society to provide the requisite information in terms of provisions of section 139 of DCS Act 2003 read with rule 165 of DCS Rules 2007 within 7 days of receipt of the order under acknowledgement.

Further a show cause notice was issued to the respondent society vide letter no. F.DRCS/U/S-139/110/2023/202-203 dated 28/02/2024 with the direction to submit its written reply in the matter.

Accordingly the then President (Sh. Tejinder Bawa) while raising various objections, agreed to provide the requisite information to the applicant. Pursuant to the same, vide office letter dated 14.06.2024 the applicant was directed to visit the society's office to receive the desired/requisite information under prior intimation to the then managing committee. Meanwhile, vide hearing dated 24/06/2024 in this matter One Sh. Ram Parkesh Sharma office Assistant appeared on behalf of the society and agreed to provide the requisite document to the applicant latest by 20/07/2024.

However, even then the applicant was not provided the requisite information therefore, vide letter dated 04/07/2024 the president/secretary once again directed to provide said information to the applicant.

However, it has been learnt that the applicant has still not been furnished the requisite information despite lapse of considerable time.

In view of above, this has become quite evident that the managing committee headed by the president Sh. Tejinder Bawa has deliberately denied the requisite information to the applicant despite directions from the undersigned.

Accordingly, I am of the firm view that the erstwhile MC kept pending the application U/s 139 on one pretext or other, and failed to provide the suitable reply despite directions from this office. Which is blatant violation of section 139 of DCS Act, 2003 and Rule 165 of DCS Rules, 2007 Hence a fine/penalty of Rs. 10,000/- (Rs. 250/- per day) is imposed upon the Sh. Tejinder Bawa President of erstwhile Managing Committee of Respondent Society which shall be deposited within 30 days of the issue of this order in the Cooperative Education Fund of Registrar Cooperative Societies. The penalty of Rs. 10,000/- is recoverable from his personal pocket of the erstwhile committee members of concerned information Officer, as arrears of land revenue. The appeal is disposed of accordingly.
