ORDER

Whereas, the New Inderprastha CHBS Ltd., 91-Inder Enclave, Rohtak Road, New Delhi-110087 is registered with this Department vide Regn. No. 1462 (HB) under the provisions of DCS Act and Rules.

And whereas, this office vide letter dated 18.08.2025 the MC of the Society was directed to provide the essential records/documents as mentioned in the said letter pertaining to the present status of the Society.

And whereas, this office vide Show Cause Notices U/s 35(5) of the DCS Act, 2003, dated 22.09.2025 & 29.09.2025, the MC of the Society was directed to appear before the Assistant Registrar (H/Sec-05) on 26.09.2025 & 03.10.2025 at 03.30 PM. However, none appeared on behalf of Management Committee of the Society.

And whereas, the Secretary of the Society submitted replies dated 26.08.2025 & 26.09.2025 in which he did not provide the relevant records/documents as sought by this Office vide letter dated 18.08.2025. Also, replies furnished by the Secretary of the Society are found not satisfactory.

Now, therefore, the undersigned is directed to convey the approval of Worthy Registrar Co-operative Societies, GNCT of Delhi in exercise of the powers vested in him under DCS Act 2003 & Rules 2007, is pleased to appoint **Sh. Ram Kumar Savant, Section Officer (Grade-I)** U/s 35(5) of the DCS Act, 2003 for next 90(Ninety) days to manage the affairs of the society and conduct the election of the Managing Committee of the New Inderprastha CHBS Ltd. as per the guidelines for the elections available in Rule 53 of Schedule II of DCS Rules, 2007. The Administrator-cum-R.O., on expiry of the period of next 90 days will not exercise any financial powers till the term is further extended by the Competent Authority. An honorarium of Rs.10,000/-(Rupees Ten Thousand Only) per Month plus other expenses will be paid to him from the society funds.
