ORDER

Whereas, Delhi High Court Employees Thrift and Credit Society Ltd. (Regd. No. 267 T/C), Regd. Address High Court of Delhi, Sher Shah Suri Marg, New Delhi (*hereinafter referred to as 'Society'*), is registered with this department under the provisions of Delhi Cooperative Societies Act, 2003 (*hereinafter referred to as 'Act'*) and rules framed thereunder.

Whereas, the Secretary of the society has informed that the last election of the society was held on 07.05.2022 and requested for appointment of Returning officer to hold the election of the society.

Whereas the term of the managing committee of the Delhi High Court Employees Thrift and Credit Society Ltd. has expired on 06.05.2025.

Now, therefore, I Surinder Narang, Assistant Registrar (Banking) O/o RCS, hereby convey the approval of the competent authority to appoint Sh. Anil Pratham, IPS (Retd.) as Administrator-cum-Returning Officer in the Delhi High Court Employees Thrift and Credit Society Ltd. under Section 35 (5) of DCS Act, 2003.

A sum of Rs. 10000/- (Rupees Ten Thousand only) per month as remuneration plus conveyance allowance will be paid to him from society's fund. The Administrator-cum-Returning Officer may hold election within a period of 90 days.

The expenses for conducting the election shall be met out from the fund of the society. The election of Managing Committee of the society shall be conducted as per the provisions of the Act & Rules of DCS Act.
