
Sub:- Engagement of drivers on outsource basis in the Revenue Department-reg.

I am directed to convey the approval of Secretary (Revenue)-cum-Divisional Commissioner, Govt. of NCT of Delhi, in continuation of the Finance Department, Govt. of NCT of Delhi, vide their U.O. No. 56/Fin./DS1/25-26 dated 09.06.2025, towards engagement of 21 (Twenty one) Drivers, through outsource basis for the period w.e.f. 01.03.2025 to 28.02.2026 against the vacant post of Drivers, or till the vacancies are filled on regular basis whichever is earlier, as below:

The Districts shall engage the Drivers on outsource basis through GeM only, as required as per GFR, subject to observance of all codal formalities and availability of funds. The District Authorities would ensure that all the conditions are fulfilled and guidelines are followed regarding the mode of hiring and deployment of outsource staff. Further, the above approval is subject to fulfillment of all codal formalities, financial rules and regulations, GFR, Circular/OMs/Directives etc., issued by CVC/ Government of India & Govt. of NCT of Delhi in letter & spirit without fail. The district concerned may also ensure that total number of Drivers engaged on outsource basis against the vacant posts of drivers should not exceed total vacant posts of drivers at any stage.
