Please refer to online application No. 2023042307176, dated 24/04/2023 on the subject mentioned above. In this connection it is to inform you that the premise was inspected by the team of officers concerned from this department on 02/05/2023 in the presence of Mr Naveen Jai hind for fire safety point of view.

During the course of inspection followings shortcoming have been observed:-

1. Exit doors at staircase of 1.5m clear width are found not provided.
2. Two stairs of 1.5m clear width are found not provided.
3. The width of corridor/ passage leading to staircases must not be less than 1.5m or 1.8 m in case of double loaded corridor.
4. Fire Check Door found not provided
5. Ventilation system found not provided.
6. Hose Reels System & Hydrant Found nonfunctional.
7. CO detectors are found not provided.
8. MOEFA found nonfunctional.
9. Terrace fire pump is found nonfunctional.

In view of the above, fire safety certificate cannot be renewed. You are advised to rectify the said shortcomings under intimation to this department for taking further necessary action.
