In this connection, it is to inform you that the site was visited by officer concerned of this department on 16/05/2025 in the presence of Principal and observed that the shortcoming has still not complied with as issued by this department vide letter no. F6/DFS/MS/School/NDZ/2025/177 dated 26/03/2025 (copy enclosed).

In view of above, the application for issuance of Fire Safety Certificate is rejected. The occupancy of the building / premises in absence of requisite fire safety arrangements shall be at the risk and liability of the owner / occupier.

Subject: - Regarding grant of Fire Safety Certificate in r/o Amar Jeevan Public School located at F - 190, Laxmi Nagar, Delhi - 110092.

Sir,

This has a reference to your Outdoor diary No. 13040 dated 28/02/2025, on the subject cited above. In this connection, it is to inform you that premises was inspected by the officer concerned of this department on 18/03/2025 in the presence of Mr. Sanjay Kumar (Principal) and observed that building comprised of ground plus three upper floors.

Following shortcomings were observed during time of inspection:

1. Second staircase found removed. One fire escape of width 0.75 m is required to be provided from Ground to upper floors.
2. First-Aid-Hose Reel found removed.
3. Fire pump of 220 LPM found removed.
4. Over head water storage tank of capacity 5,000 liters found removed.
5. Exit & floors Signage's found removed at strategic location in the building.

In view of above shortcomings, the application for issuance for Fire Safety Certificate is rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk and liability of the management. The Authority/Statutory Authority may take suitable necessary action as deemed fit.
