In this connection, it is to inform you that the premises was visited by the officers concerned of this department on 03/12/2025 in presence of Sh. T. Singh (Retd. Captain) to verify the compliance of shortcomings issued by this office vide letter No. F6/DFS/MS/NDZ/2025/416 dated 25/08/2025 (copy enclosed) and found that the shortcomings are not complied in totality.

In view of above, the application for issuance of fire safety certificate cannot be considered at this stage & stand **rejected**. Further, the occupancy of the premises in the absence of requisite fire safety arrangements shall be at the risk and liability of the owner/occupier.


Sir,

This has reference to your letter no. Nil Dated 18/07/2025 & received DFS diary no. 4042 dated 23.07.2025, on the subject cited above. In this regard, it is to inform you that the site was inspected by officer concerned of this department on dated 11.08.2025 in the presence of Sh. KC Singh estate Officer and the following shortcomings were observed:-

1. Hose reel found nonfunctional.
2. MCP found nonfunctional & glass found broken.
3. Some fire extinguishers found corroded need to be replaced with new one.
4. Smoke management system found nonfunctional in basement.
5. Lift signage's "not to use lift in case of fire" not installed.
6. Pump not in auto start provision.

In view of above, Fire Safety Certificate (FSC) cannot be renewed at this stage. Therefore, you are requested to rectify above shortcomings and re submit for further consideration in the matter.
