FIRE SAFETY CERTIFICATE

Certified that the M/s Asian Guest House, Located at 1119-22, Baza Matia Mahal, Jama Masjid, Delhi-110006, comprised of **Ground + 04 Upper Floors**, **Ground Floor-** (commercial use), **1st floor-** (04 guest rooms + 01 store room), **2nd floor-** (04 guest rooms + 01 store room), **3rd floor-** (03 guest rooms), **Total 11 guest rooms**, was issued Fire Safety Certificate by this department vide letter no. F6/DFS/MS/GH/NDZ/2022/359 dated 26/07/2022. The said premise was re-inspected by the officer concerned of this department on 12/08/2025 in the presence of Sh. Mohammad Nasir (Proprietor) and found that the building is comprised of **Ground + 04 Upper Floors** and now the floor wise occupancy is **ground floor-** (commercial use), **1st floor-** (04 guest rooms + 01 store room), **2nd floor-** (04 guest rooms + 01 store room), **3rd floor-** (03 guest rooms), **4th floor-not in use as per an undertaking dated 12/08/2025**. The building has deemed complied with the fire prevention and fire safety requirements in accordance with the Rule 33 of the Delhi Fire Service Rules, 2010 and that the **premises/building is fit for occupancy class of Residential (Group A-1)**, **1st floor-** (04 guest rooms), **2nd floor-** (04 guest rooms), **3rd floor-** (03 guest rooms), **Total 11 guest rooms up to 3rd floor only**, with effect from 21/08/2025 for a period of **three years** in accordance with Rule 36 unless renewed under Rule 37 or sooner cancelled under Rule 40 and subject to compliance of the conditions under Rule 38 of the Delhi Fire Service Rules 2010 printed below.

6. All comments / directions of licensing Department shall always be permitted and followed.

8. The owner / occupier shall apply for renewal of this Fire Safety Certificate to the Director in 'Form J' (sub Rule (1) of Rule 37) along with copy of the certificate, six months prior to its expiry.
