Sir,

This has reference to letter outdoor diary No. 2789 dated 17.06.2025 on the subject cited above. In this connection, this is to inform you that the school building was visited by officer concerned from this department on 05.06.2025 in the presence of Mr. Manish Sharma, PGT (Commerce) and observed that the school building is comprised of ground plus one upper floor (two blocks). During the inspection, following shortcoming was observed:-

- 1. The width single staircase in each block is less than 1.50 meter therefore an additional fire escape staircase not less than 0.75 meter wide shall be provided for each block.
- 2. Fire extinguishers not maintained and not adequately provided.
- 3. Exit signages not provided.

In view of above shortcoming, the application for issuance for Fire Safety Certificate is rejected. The occupancy of the building/ premises in absence of requisite fire safety arrangements shall be at the risk and liability of the school management.
