Please refer to your Online Application ID. No. 2025012200884 dated 22/01/2025, on the subject cited above. In this connection, it is to inform you that the said premise was inspected by the officer concerned of this department on 10/02/2025 in the presence of Mr. Subash Vij (owner) to check the Fire safety arrangements.

During inspection, it was observed that the Guest house is running at Ground + 03 upper floor, total 18 guest rooms, Ground Floor (Lobby), 1<sup>st</sup> floor to 3<sup>rd</sup> floor (06 guest rooms at each floor), in a building comprised of Basement + Ground + 03 Upper Floors. Fire safety arrangements such as Fire Extinguishers, MOEFA, Pumping Arrangement & Exit Signage etc, are provided. However, following shortcomings were observed:-

- 1. Fire Check Doors rating with One Hour are found removed.
- 2. First-Aid hose reels are found removed.
- 3. Co & Smoke detectors are provided but not functional.
- 4. MOEFA is provided but not functional.
- 5. Public Address System is provided but not functional.
- 6. Terrace pump of capacity of 450 is provided but not functional.
- 7. Exit signage's are found removed at some places.

In view of above shortcomings, the application for renewal fire safety certificate is not considered at this stage & rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at the risk and liability of the owner/occupier. The licensing Authority/Statutory Authority may take suitable necessary action as deemed fit.
