**FIRE SAFETY CERTIFICATE**

Certified that the M/s Chand Palace located at 54, Arakashan Road, Pahar Ganj, New Delhi -110055, comprised of Ground + 05 upper floors: Ground floor - (reception + 03 guest rooms + 02 offices), 1<sup>st</sup> floor to 3<sup>rd</sup> floor - (09 guest rooms at each floor), 4<sup>th</sup> & 5<sup>th</sup> floor- (not in use), total 30 guest rooms upto 3<sup>rd</sup> floor was granted FSC by this department vide letter no. F6/DFS/MS/GH/NDZ/2022/458 dated 07.10.2022. The building/premises was re-inspected by the undersigned of this department on 22.10.2025 in presence of Mr. Deepak Tiwari (Manager) and found that the building have deemed complied with the fire prevention and fire safety requirements in accordance with Rule 33 of Delhi Fire Service Rules, 2010. The owner has submitted an affidavit on 23.10.2025 stating not to use any floor above third floor for any purpose. Accordingly, the premises is fit for occupancy of class "Residential" (Sub Division-A-1), ground floor - (reception + 03 guest rooms + 02 offices), 1<sup>st</sup> to 3<sup>rd</sup> floor - (09 guest rooms at each floor) for total 30 guest rooms upto 3<sup>rd</sup> floor only, with effect from 30.10.2025 for a period of three years in accordance with rule 36 unless renewed under rule 37 or sooner cancelled under rule 40 and subject to conditions under rule 38 of Delhi Fire service Rules, 2010 subject to condition printed below.

6. The owner / occupier shall submit a declaration every year in form 'K' provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on [www.dfs.delhigovt.nic.in](http://www.dfs.delhigovt.nic.in)
7. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in form 'J' [sub rule (I) of rule 37] along with a copy of this Certificate, six month prior to its expiry".
8. Any change in the occupancy shall be intimated to this Deptt. and approval shall be obtained thereto before occupancy of the same.
9. The occupancy of above 3<sup>rd</sup> floor not allowed as per clause 7.31 in UBBL-2016.
