- This certificate cannot be treated in any case for regularizations of unauthorized construction.
- Six meter road will be restored on swimming pool side within six months and affected rooms shall not be used till road is restored.
- The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director of Form 'J' [sub rule (1) of rule 37] along with a copy of this Certificate, six months prior to its expiry".
- The owner / occupier shall submit a declaration every year in form "K" provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on
