In this regard, it is to inform you that the site was visited by officers concerned of this department on dated 22.07.2025 in presence of Mr. Avdesh Kumar and observed that shortcomings issued earlier vide letter no. F6/DFS/MS/NDZ/2025/243 dated 30/05/2025, have not been complied in toto so far and work is under progress. Further, trimming of tree is also required to ensure unobstructed access for fire tenders in case of emergency.

In view of above, FSC can't be renewed till the compliance of all the shortcomings at the earliest. Therefore, you are requested to rectify all the shortcomings at the earliest for further consideration in the matter. Further, the occupancy of the building/premises in absence of requisite fire safety arrangements shall be at risk and liability of owner/occupier

Sir,

This has reference to your letter no. nil dated nil & DFS Diary no.1248 dated 02/05/2025, on the subject cited above. In this regard, it is to inform that the site was inspected by the officers concerned of this department on 19/05/2025 in the presence of Manager and the following shortcomings were observed:-

1. Fire check doors found removed and broken at some floors and door closer also found removed.
2. Detector found nonfunctional at some floors.
3. Smoke management system in basement not provided.
4. Hose reel found removed at some floors.
5. MCP found nonfunctional
6. PA system is not audible properly

In view of above shortcomings, the application of renewal of Fire Safety Certificate is rejected. The occupancy of the building/premises in absence of requisite fire safety arrangements shall be at risk and liability of owner/occupier. The licensing /statuary authority may take suitable necessary action as deemed fit.
