The above mentioned officers will perform the work of Inspector of lift for the purpose of issue/grant of license to work a lift/erection permission under the provisions of the Bombay Lift Act, 1939 as extended to NCT of Delhi and periodical inspection under the provisions of the Central Electricity Authority (Measures Relating to Safety and Electric Supply) Regulation, 2023. The above mentioned DEIs shall also function as Enquiry Officers under the conditions for the grant of Certificate of Competency to Electrical Supervisor, Electrician and License to Electrical Contractors, 2016 in their concerned districts.

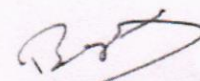
The Electrical Overseers posted in the districts will assist the concerned EI/DEI/AEI of the respective districts. The Electrical Overseers will report to the Assistant Electrical Inspector, Assistant Electrical Inspector report to the Dy. Electrical Inspector and Dy. Electrical Inspector report to the Electrical Inspector.

Dr.A.V.Koteswara Rao, DEI, Sh. Amit Dabas, AEI, Sh. Tarun Chhikara, EO will look after the work of Headquarter, Electrical Inspectorate as DEI(HQ-1), AEI (HQ)-1, EO(HQ)-1 respectively. DEI (HQ-1) shall function as DEI (HQ) for the purpose of RTI. They will look after the work related to RTI, returns related to RTI, all policy matters related to lifts and electricity, external audit/inspection, miscellaneous matters related to CEA, DERC and any other work assigned by the Electrical Inspector time to time.

Sh.Umesh Kumar Rai, DEI, Sh. Daya Ram, AEI, Sh. Raghav Kumar, EO will look after the work of Headquarter, Electrical Inspectorate as DEI(HQ-2), AEI (HQ)-2, EO(HQ)-2 respectively. They will look after the work related to monthly reports, returns related to accident matters, e-district related matters, HQ records, updating of data in Department's web site and any other work assigned by the Electrical Inspector time to time.

Sh. Mukesh Kumar Sharma, Electrical Inspector will continue with the Incharge Electrical Inspectorate.

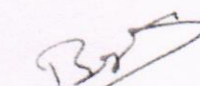
