Please refer to your letter No.6913 dated 17.5.2019 on the subject cited above. In this connection it is to inform you that the above said building has been inspected by the officer concerned of this department on 11.7.2019 in presence of Sh. Anil Kaushal (Secretary) & Sh. Rajinder Kumar (Asstt. Section Officer) to see the workability of fire safety arrangements provided there in.

During the course of inspection following shortcomings have been observed:-

1. Some of the Fire extinguishers are not refilled/repaired.
2. First Aid Hose reel are provided but not functional.
3. Fire Alarm System is provided but not functional.
4. Internal hydrants are provided but not functional as some of adopters are missing.
5. Fire pumps found non functional.
6. Terrace tank for firefighting is damaged due to some renovation work on terrace.

In view of the above shortcomings Fire safety certificate cannot be renewed. You are advised to rectify the shortcomings under intimation to this department for taking further necessary action. In absence of non function of fire fighting systems any loss be your risk & responsibility.
