Sir,

This has reference to your NO.DMRC/S&R/FSC/L-3/2024/29 dated 07/11/2024, on the subject cited above. In this regard, it is to inform you that the site was inspected by the officers concerned of this department on 14.01.2025 in the presence of Sh. Sayyam, Manager and following shortcomings were observed: -

1. Detectors found nonfunctional at some places.
2. MCP and PA system found non functional.
3. Smoke management system is not integrated with detection /MCP.

Hence, the case is rejected and Fire Safety Certificate (FSC) cannot be renewed at this stage due to above shortcomings. Therefore, you are requested to rectify the above shortcomings for further consideration in the matter.
