Subject:- Revision of retainership fees payable to the Standing Counsels / Addl. Standing Counsels and Case fees payable to the counsels in the National Green Tribunal and Delhi High Court

The Competent Authority CEO (DJB) vide order dated 18.12.2024 has been pleased to approve the revised retainership fees payable to Standing Counsels / Addl. Standing Counsels and case fees payable to the counsels in the National Green Tribunal and Delhi High Court as under:-

Monthly Retainer ship fees of Standing Counsel (Supreme Court / High Court / NGT / CAT) --- Rs 35,000/-

Monthly Retainer ship fees of Additional Standing Counsel (Supreme Court / High Court / NGT / CAT) --- Rs 25,000/-

Fees for cases before High Court and NGT –

Nature of work	Fees payable to Standing Counsel / Additional Standing Counsel	Fees payable to panel counsels
Appearance : Suits, Writ Petitions and Appeals, including Oral Applications, Revision Petitions, Special Civil Applications, OA , MA, IA, EA etc.	Rs 8,000/- per case per day of effective hearing subject to a maximum of Rs 40,000/- per case In case of non effective hearing Rs 2,000/- per case per day subject to a maximum of 05 hearings	Rs 2,000/- per case per day of effective hearing subject to a maximum of Rs 10,000/- per case In case of non effective hearing Rs 500/- per case per day subject to a maximum of 05 hearings
Drafting of Writ Petitions, Suits, Arbitrations Matters etc.	Rs 7,500/- per case	Rs 2,000/- per case



Drafting of Appeal / Revision	Rs 3,500/- per appeal / revision	Rs 2,000/- per case
Drafting of MA / other petitions including interim motions, notices, leave application, Arbitration, Company Matters and other Land Acquisition references applications for Leave to Appeal in Writ Petitions, Affidavits, Counter Affidavit, Reply etc.	Rs 2,000/- per case / per application (max. Rs 10,000/- per case)	Rs 1,000/- per case / per application (max. Rs 5,000/- per case)
Clerkage charges	10% of fees subject to maximum of Rs 5,000/- per case	10% of fees subject to maximum of Rs 2,400/- per case

These fee rates shall be effective for payment in ongoing cases as on date and forthcoming cases before NGT. However, they shall be applicable w.e.f. January, 2025 in respect of retainership fees of the Standing / Addl. Standing Counsels and for the cases in Delhi High Court filed in 2025 & onwards.
