## OFFICE ORDER NO: 01

Consequent upon the approval of Chief Executive Officer, Delhi Jal Board, the following senior most Superintending Engineers (Civil) are hereby entrusted the Current Duty Charge/Look After Charge to the post of Chief Engineer (Civil) with immediate effect as an interim/stop gap arrangement on functional requirement, till such time these posts are filled in on regular basis or till retirement on attaining the age of superannuation or till further orders, whichever is earlier:-

Further, the above arrangement is subject to the following terms and conditions:-

- (i) The entrustment of look after charge is a stop gap arrangement and the officer will draw the salary of the post which he is holding in substantive capacity.
- (ii) It will not confer any right to the official to claim for ad-hoc/regular promotion to the post or any other service benefit.
- (iii) The period of service rendered on look after charge will not count as officiating in the higher grade for any purpose.
- (iv) The Competent Authority can terminate the interim arrangement at any time without assigning any reason or giving any prior notice.
- (v) Other conditions of service will be governed by the relevant rules and orders that may be in force from time to time.
