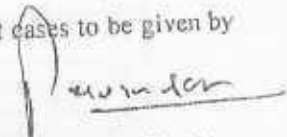

Further, the above arrangement is subject to the following terms and conditions:-

- The entrustment of look after charge is a stop gap arrangement and the officer will draw the salary of the post which he is holding in substantive capacity.
- It will not confer any right to the official to claim for ad-hoc/regular promotion to the post or any other service benefit.
- The period of service rendered on look after charge will not count as officiating in the higher grade for any purpose.
- The Competent Authority can terminate the interim arrangement at any time without assigning any reason or giving any prior notice.
- Other conditions of service will be governed by the relevant rules and orders that may be in force from time to time.
- This CDC/look after charge shall be subject to the decision in different cases to be given by different Courts.
