**Subject: - Restructuring of Projects/Planning/Quality Control Wings in Delhi Jal Board**

In continuation of office order no. 131 dated 01.08.2024, the following restructuring of Projects/Planning/Quality Control Wings is hereby ordered:-

**(A) Chief Engineer(Civil) :** The total sanctioned strength of Chief Engineer (Civil) would be 09 (nine) as per following allocation of work:-

1. The Water Projects of DJB would be divided into two parts i.e. Water Project-I and Water Project-II similarly the Drainage Projects would be divided into two parts i.e. Drainage Project-I and Drainage Project-II. Each part would be headed by a Chief Engineer (Civil).
2. There would be one Chief Engineer (Civil) who would be in charge of Planning/Quality Control Division.
3. Allocation of 04 (four) Chief Engineer (Civil) has already been decided by the Competent Authority vide Office Order No. 131 dated 01.08.2024. Thus there would be a total of 09 (nine) posts of Chief Engineer (Civil) as under:-

(i)	Zonal Chief Engineers	:	04 (Four)
(ii)	Chief Engineer(Water)Project	:	02(Two)
(iii)	Chief Engineer(Drainage)Project	:	02(Two)
(iv)	Chief Engineer(P&D/QC)	:	01(One)

**(B) Superintending Engineer(Civil) :** The total sanctioned strength of Superintending Engineer (Civil) would be 27 (twenty seven) as per following allocation of work:-

1. Chief Engineer (Water) Project-I would be assisted by 02 Superintending Engineer (Civil).
2. Chief Engineer (Water) Project-II would be assisted by 03 Superintending Engineer (Civil).
3. Chief Engineer (Drainage) Project-I would be assisted by 03 Superintending Engineer (Civil).
4. Chief Engineer (Drainage) Project-II would be assisted by 03 Superintending Engineer (Civil).
5. Chief Engineer (P&D/QC) would be assisted by 03 Superintending Engineer (Civil).
6. There would be one post of SE(Vigilance) who will report to Chief Vigilance Officer, DJB



7. There would be one post of SE to be designated as Director(S&DM) who will report to Member (Drainage)/CE(Nodal)Drainage.
8. Besides, there would be two SEs- one handling Ground Water to be known as SE(GW) and the other handling Rain Water Harvesting & Water Bodies to be known as SE(RWH/WB).
9. As per Office Order No. 131 dated 01.08.2024 there would be 11 Superintending Engineer (Civil) who would assist the Zonal Chief Engineers.
