This is with reference to the email received from Id: satesh@aiims.gov.in dated 05/03/2025, on the subject cited above. In this connection, it is to inform you that the said premise was inspected by the officer concerned of this department on dated 26/04/2025 to see the performance of fire protection measure in the presence of Sh. Harinder Singh (Dy. CSO). During the inspection, the shortcomings observed are as below.

1. Electrical shaft found unsealed vertically & horizontally at some levels.
2. Smoke exhaust system in basement found non-functional.
3. First Aid hose-reel found non-functional.
4. Automatic fire detection system found non-functional at some places.
5. Manually operated electrical call points found non-functional.
6. Automatic sprinkler system needs to be extended in left out area in basement.
7. Hose boxes near internal and external hydrants found without hoses & branch.
8. Lift was under installation.

In view of the above, the application for renewal of Fire Safety Certificate is rejected. You are advised to rectify the shortcomings under intimation to this department for further action in the matter.
