Pramod Sharma (President) to see the compliance of the shortcomings communicated vide this office letter No. F6/DFS/MS/CGHS/SZ/2024/667, dated 11/12/2024 & found that the shortcomings are still not complied.

In view of the above shortcomings renewal of Fire Safety Certificate from fire safety point of view cannot be considered at this stage. You are directed to comply all the shortcomings under intimation with this department for further consideration in the matter. The occupancy of the building premises without valid Fire Safety Certificate is on the risk and responsibility of the management committee

Please refer to your letter No. TDCGHS/2024-25/6 dated-12/11/2024 on the subject cited above. In this connection it is to inform to you that the above said premises was inspected by the officer concerned of this department on 29/11/2024 in the presence of Sh. S. Dutta (Secretary) from fire safety point of view.

During the course of inspection followings shortcoming were observed:-

1. Six meter wide internal road around the building found encroached/blocked.
2. Staircases found partially blocked.
3. Hose Reels & Hydrants system found nonfunctional.
4. MOEFA & PA system found nonfunctional.
5. All the pumps found nonfunctional.
6. Exit signage's found removed at some places.
7. Communication system found removed in lift car.

In view of the above shortcomings renewal of Fire Safety Certificate from fire safety point of view cannot be considered at this stage. You are directed to comply the shortcomings under intimation to this department for further consideration in the matter. The occupancy of the building premises without valid Fire Safety Certificate is on the risk and responsibility of the management committee.
