Sub:- Regarding Issuance of Fire Safety Certificate.

Sir,

This is in reference to your letter No. nil dated 19/02/18 on the subject cited above. In this connection, it is to inform you that the officer concerned of this department has carried out the inspection of the above mentioned school from fire safety point of view in presence of Mrs. Chitra Pravin, Principal of the School on 10/05/2018. During the course of inspection, the following points / shortcomings were noticed in the building comprised of ground plus two upper floors.

- 1. Only 02 fire extinguishers provided in place of 06 fire extinguishers as required.
- 2. First-Aid hose reel (01 nos.) at each floor not provided.
- 3. A fire pump having 450 LPM output at 40 meters head not provided.
- 4. Over Head water storage tank 10,000 liters capacity exclusively for fire fighting not provided at terrace.
- 5. Exit Signage not provided.

In view of above, the building can not be considered for issue of Fire Safety Certificate at this stage. Therefore you are suggested to rectify the above mentioned shortcomings under the intimation to this department for further course of action.
