The corporate entity partner would make payments directly to the supplier. DJB would supervise the process of installation and make sure that land is available for such installation. Post installation, DJB would take over the responsibility of operation and maintenance, for which the vendor would need to provide demonstration and manual of instructions to DJB officials.

These interventions will be strategically deployed along critical drains and locations directly impacting Yamuna's water quality.


