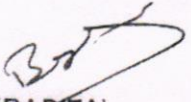

In respect of matters of electrical installation of accident sites vide this department order No. F. No. F/31/125/LC/Esstt./12/IV/717 dated 11/7/2017 and matters of lift accidents, the concerned district Electrical Overseer will carry out the inspections as directed by the District AEI. The concerned district AEI shall mark the request/ intimation letter to the concerned Electrical Overseer for inspection. After inspection, the Electrical Overseer shall submit the Technical Inspection Report to the concerned district AEI for further necessary action. As and when required and directed by the Incharge of Electrical Inspectorate, electrical installation of accidents sites/lift accident cases may also be inspected by the concerned district AEI/DEI/EI keeping in view the seriousness of the matter.

It is also directed that the above EOs shall also perform any other duties and functions as assigned by the concern AEI/DEI/EI from time to time in any Act/Rules/work etc. enforces by the Electrical Inspectorate. The Electrical Overseers will report to the Assistant Electrical Inspector, Assistant Electrical Inspector report to the Dy. Electrical Inspector and Dy. Electrical Inspector report to the Electrical Inspector.

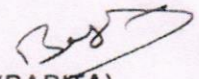
