stage.

Sir,

Please refer to your letter No.54(45)/A.E.(E)-4/P.W.D/M-1/2024-25/05 dated: 10/03/2025 on the subject cited above. In this connection this is to inform you that the above mentioned site was visited by the officer concerned of this department on 26/04/2025 to verify the fire safety measures issued vide NBC Part-IV/UBBL-2016 and observed that the building was comprised of ground & 03 upper floors only. At the time of inspection Sh. Pradeep Kumar (Principal) was also present at site. During the course of inspection observations/ shortcomings made are as under:-

- 1 Hose reel hose is provided but not functional and all hose reel nozzles found missing.
- 2 Terrace level fire fighting pump capacity of 450lpm is provided but not functional.
- 3 Terrace level water tank for firefighting capacity of 10,000 ltrs is provided but domestic connection is provided.
- 4 Exit signage is not provided at strategic locations in the school building.
- 5 Standby power supply is not provided.
- 6 Electrical panel below staircase needs to be removed/shifted in a safer place.
- As built plan of the new school building shall also be submitted.

Keeping in view of above, grant of Fire Safety Certificate cannot be considered at this stage & rejected. You are requested to rectify the above mentioned shortcomings under intimation to this department; till such time running of new school building is at your own risk & responsibility.
